Sent in a deposit for \$84,831.66 including Q4 sustainability funds, RCD reimbursement for CVERA equipment, and Cal Fire VFC funding.

Valley Roofing coming to replace gutters on both sides of Station 22

Matt fixed foam systems on E22 and B222, B21 back from pump rebuild and pumping 300GPM New resident interested in joining – Victor lives up in Rumsey. This would bring our roster up to 24 and possibly necessitate a small academy for probational firefighters.

We have had many mutual aid requests recently and having trouble providing anything but a water tender as there is no other agency to provide coverage for us.

Made it through the PSPS with no incidents – we pulled in volunteers and compensated them for taking the day off work during the red flag event, and CVERA staffed a cooling station here at 22 until the power came back on.

21 calls in June, shaping up to be a busy summer.

Firefighters' Association Report:

4th of July barbeque was good, the association brought in about \$700 from the raffle and t-shirt sales. The kids loved the water slide and the sprinkler, the fireworks all came from the Esparto Little League and we were happy to support them. Nothing else coming up until Fire Prevention Week.
